School Plan

The school is located 2 miles north of Freeport Center, 2 miles west of the 1-15 Interstate and is close to Hill Air Force Base.

Surrounding Cities:

Clinton 1 block north

West Point 0.75 miles west

Sunset 1 mile northeast

Syracuse 3 miles south

Layton 5.5 miles south

Traffic Controls

There are traffic lights at 300 N. and 1000 W., SR-193 and 1000 W., and 800 N. and 1000 W. The posted speed limit is 35 miles per hour on 300 N. and 1000 W. and 30 miles per hour on 800 N.

Established School Crossing

There are two school crossings zones. Drivers are directed to slow to 20 miles per hour. Each crossing zone has signage, a crossing guard, flashing lights, painted crosswalks, and orange cones are used during crossing times. There is a 3rd crossing guard at 300 N. and 1000 W; however, there is no required reduction in speed or flashing lights at this location. The crossing guard crosses students according to the traffic light.

Present Access Routes

- At the intersection of 300 N. and 1000 W., children walking from Westwood and Mane Estates walk north to 300 N. to cross.
- Students from Cambridge Mobile Home Park walk along 450 N. through Sundowner Mobile Home Park and cross at the 525 N. 1000 W. crossing.
- On the corner of 300 N. and Barlow Street, students who live in Rose Garden Estates walk down 450 N. to the Barlow subdivision then continue to 300 N. and on to the school.

- Students from Sundowner Mobile Home Park, Country Village, Lori Estates, and 800 N. will use the crosswalk at 525 N. and 1000 W.
- Students from Westwood Estates will walk north on 1000 W. on sidewalks and cross with a crossing guard at the intersection of 300 N. and 1000 W. Students can also walk east on 300 N., on the sidewalk, to the crossing guard at 300 N. and 1000 W.
- Students leaving 360 W., 400 W., or 500 W. will walk west on the south side of 300 N. They will cross over to the north side of the street at Barlow Street with the aid of a crossing guard. They will continue to walk west to 1000 W. and walk north to school.
- Students walking from 1000 W. and 700 N. (on the east side of 1000 W.) use the east sidewalk on 1000 W. to the school.
- Students walking from Autumn Ridge Subdivision walk from 25 S. to 1000 W. and proceed north to 300 N. where they cross with the assistance of a crossing guard.

Established Speed School Zones

- 300 N. and Barlow Street
- 525 N. and 1000 W.

Sidewalks

Most routes have sidewalks except for the following:

- 1500 W. from 300 N. to 800 N.
- In front of a few homes or businesses on 300 N.
- East side of 1000 W. near Miya's Farm
- 300 N. onto Pacific Avenue

Bike Routes

Bike and walking routes are the same. Bike racks are located behind the school. Students are instructed to follow safe biking rules and walk their bikes while crossing streets and while on school grounds.

Loading and Unloading Areas

There are two parking lots in the front of the school. Parents can enter on the south side of either lot and exit on the north and load and unload students along the sidewalk. When busses come for any purpose, they will use the south loop.

Parents also use Clearfield City parking lots to drop off and pick up students. One lot is located north of the school and the other is south and east. Students walking to and from these parking lots use designated sidewalks to access the school building.

Implementation of Plan
